## **BILLS**

Bills for March 28, 2022 were presented and approved with Commissioner Deans making the motion and Commissioner Behrens seconded. All in favor Motion carried. 5-0

- 4. The court approved a request to bury a new PVC conduit and fiber-optic cable within the east R.O.W. of CR 122 in Precinct 1 from CTTC's existing DLC cable cabinet #DLCZE at the intersection of CR 122 and FM 2028, extending approximately 5,700' south and exiting into private property to the west at 670 CR 122 Melvin, Tx. for telecommunications service to a resident of precinct #1. Commissioner Deans made the motion with Commissioner Behrens seconded. All in favor Motion carries. 5-0
- 5. The Commissioner's court discussed and adopted a 30 day burn ban for McCulloch County from the date of this application. Commissioner Deans made the motion with Commissioner Kemp seconded. All in favor Motion carries. 5-0
- 6. The court acted and approved a contract for professional services between McCulloch County and Allison, Bass & Magee LLP for assistance with the subdivision regulations. Commissioner Behrens made the motion with Commissioner Anderson seconded. All in favor Motion caries. 5-0
