**Action:**

1. The Court heard from Taylor Hoffpaur Chamber Director for the use of the Courthouse Lawn for Christmas in the Heart to be held on Saturday December 10, 2022. The Clergy Association and the Brady/McCulloch County Chamber of Commerce requested special permission to bring in snow to the Courthouse lawn as an addition to the event this year. The court approved with Commissioner Deans making the motion with Commissioner Anderson seconded. All in favor Motion carries. 4-0.
2. The Court approved the request by CTTC to extend its existing buried fiber communications cables within the ROW of McCulloch CR 350, from its exiting splice point #903-11L-3/HH1 extending approximately 485’ south, then 450’ west, thence exiting the ROW to the south and entering private property in Salt Gap. Commissioner Behrens made the motion with Commissioner Anderson seconded. All in favor Motion carries. 4-0.
3. The Court approved the request by CTTC to extend its existing buried fiber communications cables within the ROW of McCulloch CR 308 at Pear Valley. The Extension will begin at CTTC’s existing splice #703-10-11L/HH5 to extend southeast within the ROW approximately 5,080’ then exit the ROW to the West. Commissioner Behrens made the motion with Commissioner Deans seconded. All in favor Motion carries. 4-0
4. The Court acted and approved a Resolution authorizing the County Grant program year 2023 for the Texas Department of Agriculture Texans Feeding Texans: Home-Delivered Meal Grant Program. Commissioner Deans made the motion and Commissioner Anderson seconded. All in favor Motion carried. 4-0
5. McCulloch County Commissioners agreed on the Indigent Cremation fees being raised from \$750.00 to \$1000.00. Commissioner Anderson made the motion and Commissioner Deans seconded. All in favor Motion carries. 4-0
