- Discussion on the Matterhorn Express Pipeline, LLC request approval to bore a 42 inch outside diameter steel pipe under the County Right-of-Way in Precinct 3 County Roads 350,330,346 and 300 and Precinct 4 County Roads 462 and 468 to transport natural gas, also to install temporary access driveways on both sides of the mentioned County Roads during the pipeline construction and a permanent driveway access will be installed on the west side of County Road 300 for access to mainline valve.
- Discussion on the lack of bids for the 301 E Commerce Street was held with all Commissioners not wanting to lower the asking price, instead they want to look at different advertisement and marketing avenues and revisit the issue at a later date.
