**Elected Officials/Department Heads:** Sheriff Matt Andrews let the court know that the Sheriff's Department got heart and respiration monitors for inmates that may need it while housed in jail. The cost of \$24,600.00 install with a computer being furnished at \$3,600.00 a year. The system will sound an alarm is something is going wrong with an inmate that is in the cell with the installed system. There can and will be only one inmate in the monitored cell at any time.

**Discussion:** Discussion was held on the expired FEMA HAZARDOUS MITIGATION PLAN. Judge Trull let the court know that the FEMA plan was too much for one person to handle. Would like to hire an Administrator for the FEMA Hazardous Mitigation Plan at the cost of about \$80,000 to \$90,000 per year. **Action:**

- The Court discussed, acted, and approved the purchase of a new laptop and monitor to be used in the courtroom to help with implementing the Pre-Trial Diversion program and purchasing with PTD funds. - 4. The Court discussed, acted, and approved an Agreement to house inmates for San Saba County at a rate of \$55.00 for males and females and \$60.00 for special needs inmates. Commissioner Behrens made the motion with Commissioner Bratton seconded. All in favor Motion carries. 4-0.
- 5. The Court discussed, acted, and approved the 2023-2024 Investment Policy for McCulloch County as presented by County Treasure Mikkie Williams. Commissioner Anderson made the motion with Commissioner Bratton seconded. All in favor Motion carries. 4-0
