Bills for December 23, 2024 were presented and approved with Commissioner Behrens making the motion and Commissioner Deans seconded. All in favor Motion carried. 5-0


Elected Officials/Department Heads: County Judge Frank Trull announced that the Swearing in Ceremony for all recently elected officials will be held on January 1, 2025 at 9:00 AM here at the McCulloch County Courthouse.

Discussion:

Action:

1. The Court acted and approved a service agreement between CTWP and McCulloch County for the copier in the Veterans Service office in the amount of \$35.00 per month. CTWP retains ownership of the copier. Commissioner Deans made the motion with Commissioner Bratton seconded. All in favor Motion carries. 5-0.
2. The Court acted and approved the purchase of a 2025 Model DE16g-3 7x16 Dump Truck from Magnum Trailers. This purchase will come from CSLFRF equipment funds for Pct. #3 in the amount of \$20,600.50. Commissioner Deans made the motion and Commissioner Bratton seconded. All in favor Motion carries. 5-0.
3. The Court acted and approved a purchase of a 2025 Model TA20 25+5 equipment trailer from Magnum Trailers. This purchase will come from CSLFRF equipment funds for Pct. #3 in the amount of \$36,305.50. Commissioner Bratton made the motion with Commissioner Deans seconded. All in favor Motion carried. 5-0
4. The Court considered and approved a Memorandum of Understanding between the Haven Family Shelter and McCulloch County regarding the use of CSLFRF funds in the amount of \$12,000.00 for client hygiene and food products. Commissioner Behrens made the motion with Commissioner Anderson seconded. All in favor Motion carried. 5-0
5. The Court acted and approved the use of allocated CSLFRF funds in the amount of \$109,297.99 for Vital, Criminal, and Probate Record restoration for the County Clerk's Office. Commissioner Deans made the motion with Commissioner Behrens seconded. All in favor Motion carries. 5-0

Having no further business, the meeting adjourned at 10:43 AM with Commissioner Behrens making the motion and seconded by Commissioner Deans. All in favor motion carried. 5-0
