Judge Trull gave update on SERI Grant, and reported that EMS numbers are in by Erin Corbell from the City of Brady. He emailed all the Commissioners the report.

Commissioner Bratton reported that Halstead street needs work and that he is trying to work with the City of Brady on South Ave.
