TESTIMONY – INCLUDING KELLY/DAUBERT/ROBINSON MOTIONS MUST BE SCHEDULED  
AND HEARD AT LEAST 10 DAYS PRIOR TO THE DATE OF TRIAL.**

EXCEPTION TO THIS RULE.**
