ALL OBJECTIONS TO EXPERT WITNESSES AND/OR MOTIONS TO EXCLUDE EXPERT TESTIMONY, INCLUDING KELLY/DAUBERT/ROBINSON MOTIONS MUST BE SCHEDULED AND HEARD AT LEAST 10 DAYS PRIOR TO THE DATE OF TRIAL. LAST MINUTE DESIGNATION, SUPPLEMENTATION, ETC. WILL NOT BE CAUSE FOR AN EXCEPTION TO THIS RULE.
